Regulation

Scrapping promotion and overvaluation of FM transmitters

1. Customers - Duration of the promotion

The promotion is valid all over the world: the customers could join it by filling the "Application form" and only by purchasing any FM transmitter marked DB Digital Broadcast from 1st June to 31st July 2019.

2. General structure

With this promotion DB will grant the pre-defined value (see table) as a discount, following the activation of the application procedure, in relation to the new DB products Digital Broadcast purchase, up to a maximum of 10% of the new transmitters ordered value. We accept a maximum of one scrapped device per customer / promotion.

3. How to send the "Application Form"

The registration form, duly completed in all its parts, has to be sent to DB by e-mail to the following address: sales@dbbroadcast.com

4. Conditions for granting pre-defined value

By adhering to the promotion, the Customer can take advantage of a guaranteed incentive to the purchase of the new DB products (as per Table on page 2 "Evaluation table Euro / kW ") up to a maximum of 10% of the value of the new transmitters ordered value. These values could be applied only if the scrapping/buy back products are still functional and complete with all parts and accessories provided in the original configuration. They must not have any damage. However, DB will decide, at its exclusive and final discretion, whether the old transmitter must be shipped to its headquarters, with transport charged to DB, or to leave them to the customer granting anyway the predefined promotion value. If DB will receive any non-working or damaged transmitters, they will be returned to the customer, charging the shipping costs with regular invoice.

5. Terms and conditions of the evaluation's payment

The guaranteed evaluation will be applied through a discount on the purchase of a new DB transmitter.

6. Liability on data contained in the returned transmitters

Before the delivery of any used transmitter to DB, the Customer is required to delete the data stored in and of belonging to the owner and, by the way:

- The Customer declares to be the owner of the transmitter sent to DB, unless there are no pending issues and to be aware that, following the delivery, he will loose any rights upon the related software licenses.
- The Customer declares that the transmitters are not subject to investigations of Judicial Police.
- The customer, releasing DB now by then from any liability, declares to hold DB harmless from and against any action / claim / request or instance due to non-compliance to the truth of the above customer declarations.
